Dr. Cirillo has been a practicing emergency physician for over 30 years and in addition to his clinical practice, serves as the Director of Government Affairs for US Acute Care Solutions. He is a past chair of ACEP's Federal Government Affairs, State Legislative and Regulatory and Membership Committees. Dr. Cirillo is a Past-Chair of the Emergency Medicine Policy Institute (EMPI) Board of Governors.

Dr. Cirillo is the 2018 recipient of ACEP's Collin C. Rorrie, Jr. Health Policy Award. He is a strong supporter of emergency physician advocacy in health policy and is a passionate advocate for improving the systems of care in this country for patients with mental illness. D r. Transfer and Transport in the Age of Constrained Capacity

Dr. Dinerman serves as the Medical Director, LifeFlight of Maine. He is also the Medical Director of the Northern Light Health Transfer Center. He serves as a physician advisor to the Emergency Medical Treatment and Active Labor Act (EMTALA) compliance program. In these positions, he provides medical oversight of the system for transfer and transport of patients throughout the region, the statewide LifeFlight of Maine air and ground critical care transport teams and the MedComm Communications Center. He is an active participant in national, local and statewide activities which bear upon "peri-hospital" care of patients. His clinical practice is that of emergency medicine and critical care transport medicine aboard LifeFlight aircraft and ground ambulances. Of late, he has focused considerable effort on improving patient flow and institutional capacity, particularly as it affects the ability of a hospital to manage the volume of patients who present with an unscheduled demand for care. Optimizing the creativity and leveraging the panoply of fragile resources of the health care tapestry is an intense focus of his work.

Dr. Dinerman served as the Chief of the Emergency Medicine Service at Eastern Maine Medical Center for eighteen years, completing his tenure in this position on Oct. 31, 2006. From June 1992 to June 1996 he served as the State EMS Medical Director for Maine. From March 1979 until October 1988 he served as the Associate Director, Department of Emergency Medicine, Denver General Hospital, Denver, Colorado, as well as the Director and Physician Advisor to the Paramedic Division for the Denver Department of Health and Hospitals and Physician Advisor to the Denver Fire Department. During the same period, he served as the Agency Disaster Coordinator for the Denver Department of Health and Hospitals. He is a former member of the National Association of EMS Physicians where he served as the Chairman of the Legal Affairs Committee. He has served as a member of the EMS Technical Assistance Team for the National Highway Transportation Safety Administration on multiple occasions. He lectured as a charter faculty member of the National EMS Medical Directors' Course and Practicum for more than twelve years.

Dr. Dinerman is a native of New York City and received his undergraduate education at Columbia University and his medical degree from Yale University. He completed his internship and residency in Internal Medicine at the University of Colorado Health Sciences Center, Denver, Colorado. He is Board Certified in Internal Medicine and Emergency Medicine. He received his flight training to become a licensed pilot, in Denver, Colorado,

Emily M. Hayden, MD, MHPE is an attending physician and Director of Telehealth and Associate Director of the Virtual Observation Unit in the Department of Emergency Medicine at Massachusetts General Hospital. Dr. Hayden is the founding Chair of the SAEM Telehealth Interest Group, Chair of the SAEM 2020 Consensus Conference on Telehealth in Emergency Medicine, Chair of the Education Subcommittee on the ACEP Telehealth Task Force, and the Chair-elect of the ACEP Emergency Telehealth Section. She is a member of the American Association of Medical Colleges (AAMC) Telehealth Advisory Committee that developed the AAMC Telehealth Competencies. She is the Course Director for a self-paced online interprofessional telehealth course, "Telehealth Foundations: Applications Across the Professions". Dr. Hayden's research focuses on telehealth in emergency medicine, from the use of telehealth nationally for transfer coordination to the comparison of telehealth to in-person physical examinations. Prior to her work in telehealth, Dr. Hayden spent a decade in healthcare simulation and developed the TeleSimulation program at MGH Learning Laboratory at Massachusetts General Hospital.

Over the past 25 years, Dr. Daniel J. Sullivan has delivered hundreds of patient safety lectures for clinical leaders across the country at many annual industry forums, including: the Annual American Society of Healthcare Risk Management (ASHRM) Conference and the American College of Emergency Physicians (ACEP) Scientific Assembly.

Dr. Sullivan's passion and vision for patient safety have garnered him the respect of his peers while earning ACEP's Colin C. Rorrie Jr. Award for Excellence in Health Policy and ACEP's Outstanding Speaker of the Year Award. Given the recent era of healthcare IT, Dr. Sullivan has directed a significant amount of his attention towards redesigning EMR applications to improve patient safety and clinical workflow. His lectures on heuristics, human factors engineering, and EMR medical liability have been instrumental in shaping the discussion between clinicians and IT administration for many healthcare organizations across the country.
